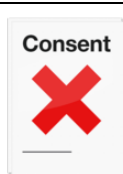

	If you choose to take part, you can have a support person with you during the project.

Do I have to take part in this project?



You do not have to take part in this project – it is your choice.

What will happen in the project?



We will contact you or your supporter to ask how you choose to communicate.

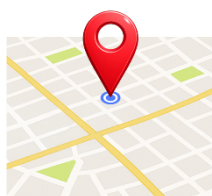


The researchers will find a time that suits you to have a chat with you. We will chat about times when you felt things were not fair.



Remember, the research team is Caroline, Emma and Mia.

The chat will be with Emma.



You choose where to have the chat:

- That might be your home.
- Or you can come to Trinity.



We will use a video camera to record the chat.



We will write down the conversation from the recordings.

We will also write down what you are looking at, or pointing to.



You will have a chance to check what has been written down.

Things to keep in mind



The chat will take around 1 and a half hours of your time.



Sometimes people may get upset when talking about things that are not fair.

A private support service will be available if you are upset. We will give you the details.



Some people find it good to share these experiences.

This project will help other nonspeaking people in the future.



This project is **voluntary**.

This means you will not be paid if you take part in this project.

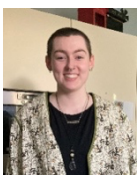
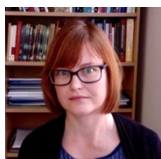
How will we look after your information?



Only you and your supporter will know that you are taking part.



The video and sound recordings will be put onto a computer with a password. We will keep the video and sound until the end of the project (December 2026).



Only Caroline, Emma and Mia will be able to see the video and hear the sound. The recording won't be shared with anybody else.

	When we write down the chat, we will change your name. We will also change any information that could let you be known. We will store the written document about the chat for 1 year so that we can write about what you told us.
	Parts of what we write down will be used in reports. Th is means some sentences might be used. We will describe what you told us. We won't share the video or the sound.

What are my rights (about my information)?

	You have rights about how your information is used and stored.
	You can ask for your information and get a copy of your information.
	You can change your mind about what information we can use.

	You can ask that we stop using your information in this project. After 1 year we won't be able to remove your information anymore.
	You can ask to change or update your information.

Who can I talk to about my information?

	If you want to get your information, or change it you can talk to us. You can also talk to us if you want us to stop using your information.
